



### **What is MiDAS for Car and MPV**

This is a similar course to MiDAS (Minibus Drivers Awareness Scheme) however it is aimed at organisations that operate smaller vehicles (up to 8 passenger seats) either exclusively or as a larger fleet.

It follows the same accreditation procedure as MiDAS including classroom based theory training along with additional training for drivers who drive accessible vehicles (one that is capable of carrying a wheelchair).

Additional training is available if you carry children with special needs or older people who require care or supervision.

### **Standard Car and MPV Training**

This is designed for drivers who do not need disability awareness and equipment training:

4 Hours of classroom based theory, topics included are:

- Driving Licence Information
- Drivers Legal Responsibilities
- 1988 Road Traffic Act
- Passenger Safety
- Seat Belt Law
- Speed Awareness
- Defensive Driving
- Health and Safety and Manual Handling Information
- Vehicle Checks and Defect Sheets
- Breakdown, Collision and Emergency Procedures

There is also the option of an observed drive. This can be opted out of if your company decides or if you are using your own car.

### **Accessible Car and MPV Training**

As above plus:

- Disability Awareness Training
- Wheelchair Handling Techniques
- Wheelchair Securing Equipment Training
- Correct Use of Passenger Lifts/Ramps

We can also incorporate two additional modules into the training package on request:

- Supervising Children and Young People With Special Needs.  
This includes working with children and young people with learning difficulties, autism, Attention Deficit Disorder and emotional and/or behavioural Difficulties.

And

- Working with Adults Who Require Care and Supervision.  
This includes adult passengers with learning difficulties, autism, dementia and mental health problems.
